- To use the funds to effectively provide for a number of scholarships.
- b) To provide funds to assist children from secondary schools in Lincolnshire to gain a university education. In particularly **GIFTED children** from Spilsby, Horncastle and Skegness, but not restricted to these areas.
- c) The monies to be used for families on lower incomes and would want the monies to be used to assist them with university fees and living expenses.
- d) Up to £1000 a term, maximum of £10,000 per successful application.

When grants will be allocated

The Trustees meet three times per year to consider applications and all submissions will be considered at the first available meeting.

Telling us about your circumstances, why are you applying for the grant and what difference will it make to you, what the money will be used for, and your achievement and ambitions for your future.
